**Half Share - \$522.75 (includes tax and a \$10.00 deposit for 2 boxes)**

A weekly share of vegetables for 2-3 people for 20 weeks. The amount of vegetables in the half-share is equivalent to \$25 per week. You will get one box of produce each week. You will return that box the next week when you pick up that week's share.

**Full Share - \$1,045.50 (includes tax and a \$20.00 deposit for 4 boxes)**

A weekly share of vegetables for 4 or more people for 20 weeks. The amount of vegetables in the full share is equivalent to \$50 per week. You will get 2 boxes of produce each week. You will return those boxes the next week when you pick up that week's share

# Detailed Information for CSA Applications

---

1. **Your first box will include a copy of The Practical Produce Cookbook.** This book will be part of your share value the first week. We will provide it to you at our cost of \$9.75. This cookbook has 332 pages packed with information to help you understand how to use the vegetables that you receive in your box every week. We find that this cookbook is invaluable to us as we strive to find new ways to incorporate vegetables into our diet.
2. **The duration of our 2012 Spring/Summer CSA season is 20 weeks.** The exact start date is weather-dependent. The expected start date will be around the last week of April or first week of May. We will notify you via e-mail or telephone of the exact start date. Once the CSA begins, weekly pickups will continue for 20 consecutive weeks. In addition to the 20-week CSA, we expect to offer a Fall CSA share. The exact dates of the Fall CSA Share and additional costs will be provided later.
3. **Your payment for the 20 week season is due in full by March 1, 2012. Your payment is NON-REFUNDABLE. If paid in full by January 1, you can take \$20 off of a half share for a total of \$502.25 and \$40 off of a full share for a total of \$1,004.50 This will give you one free week of produce.**
4. **Pick-up times and location** – All pick-ups will be at the Market on our Farm which is located at 12101 Orange Plank Rd, Locust Grove 22508 VA. **You must select one designated pick-up day that remains in effect during the length of the agreement.** Choices are Tuesday – Saturday, 1pm-4pm. See the application for more details concerning vacations, etc. We encourage you to coordinate pick-ups with friends to help save time and gas.
5. **Produce Selection** – Our goal is to provide you with a selection of fresh, high quality produce that is equivalent to a \$25 retail value per week (for half share customers) and \$50 retail value per week (for full share customers). On most weeks the value of the box will exceed the share value especially during the middle of the growing season. We package all CSA shares in the same size box (1/2 bushel) and with the same quantity of produce for each customer. We understand that everyone has preferences, but at this time substitutions will not be allowed. The Practical Produce Cookbook provides excellent recipes for all produce provided in the CSA. **If there is produce in your CSA share box that you do not like, you can leave it here and we will gladly donate it to the Food Pantry.** Since we operate a farmers market on our farm, we will have additional produce and products for sale. Additional products available for purchase in our Market include: Trickling Springs Creamery Milk and Ice cream, Roseda Beef, Papa Weavers Pork, Local Honey, Graves Mountain Jams and Pickles, and McCutcheons Products.
6. **If you would like additional produce for a special event or for freezing or canning, please let us know and we will be happy to provide you with an estimated cost and availability.**

# Miller Farms Market CSA Rules

---

1. **We allow one pick - up day change per customer and one vacation per customer.** Please see #2 and #3 below for our rules on pick-up day changes and vacation schedules. If at any time you would like to make arrangements for a friend to pick up your CSA share, please feel free to do so. This is actually very helpful to us.
2. **Scheduled Pick-up Day Change** – When you complete the CSA application, you will select one designated pick-up day that remains in effect during the length of the agreement. Pick-up location is the Market on our farm. You are responsible for picking up your share on your selected pick-up day. We allow one pick-up day change per customer, which must be coordinated with us one week in advance. Pick-up day changes that are not coordinated one week in advance will be considered a missed pick - up and your share for that week will be donated.
3. **Vacation** – We allow one vacation week per customer, which must be coordinated with us one week in advance. If you will be on vacation and unable to pick up your share one week, you must provide us with notice one week in advance in order to receive a double share the week before or the week after your vacation. Vacations that are not coordinated one week in advance will be considered a missed pick-up and your share for that week will be donated.
4. **WE DO NOT OFFER REFUNDS!**
5. **If you miss your pick-up, your share will be donated for that week.** In effort to be good stewards, we support the Food Pantry at Saint Faustina Conference Society of Saint Vincent de Paul. They are located in the Breezewood Shopping Center off of Courthouse Road. All boxes of produce that are not picked up on their designated day and any produce from your share that you do not wish to take home will be donated.
6. **You are responsible for returning your produce box each week.** Your produce share will be packaged in ½ bushel boxes. If you are getting a full share you will have (2) ½ bushel boxes. When you pick up your weekly share, please remember to return the box from the previous week. **If you forget your box, there will be a \$5.00 charge for a new box.**
